The purpose of mastering this academic discipline is to preserve the historical truth about the crimes of the Nazis and their accomplices against the civilian population of the occupied territories of the RSFSR during the Great Patriotic War.

3.3. Course Content

Section 1. Ideological and institutional foundations of Nazi crimes against humanity in the occupied territories of the RSFSR

Topic 1.1. Racial theory and the ideology of conquering "living space." Nationalist and eugenic doctrines as the basis for the policy of extermination. History of the policy of Germanization of occupied territories.

Topic 1.2. Anti-communism in Nazi policy. Germany's preparation for war. Mechanisms of extermination: the formation of security detachments, the creation of a system of concentration camps. Orders and directives for the extermination of the population. The course toward the destruction of all forms of Soviet statehood and the mass extermination of local residents.

Topic 1.3. Organizational foundations for the implementation of the racist strategy of systematic extermination of the USSR population ("war of extermination"). Order of the Commander-in-Chief of the Ground Forces, Field Marshal Werner Brauchitsch, on the "Procedure for the Use of the Security Police and SD in Ground Forces Units" (April 28, 1941). Directives exonerating military personnel and officials from any responsibility for possible crimes against the civilian population of the USSR. General Economic Headquarters "East" (April 28, 1941). Directive "On Military Jurisdiction in the Barbarossa Area and Special Powers of the Troops" (13 May 1941). Directive "On the Conduct of Troops in Russia" (19 May 1941). "Directive on the Treatment of Political Commissars" (6 June 1941). "Directives for the Conduct of Economic Affairs in the Occupied Eastern Territories" (Goering's Green Folder). "General Plan Ost". "Night and Fog" Directive (7 December 1941).

Section 2. Crimes against civilians in the occupied territories of the RSFSR

Topic 2.1. The Nazi occupation regime, punishments for its violations. Sonderkommandos. Labor service. Crimes of the Nazis against Soviet citizens. Crimes against women. Crimes against childhood. Labor camps for children. Using children to draw blood from wounded fascists. Nazi crimes against individuals with special developmental needs. The fate of patients in mental health clinics. Extermination camps: the system of administration, organization of prisoners' lives, and the use of punishment. Nazi captivity. Extermination of prisoners of war and medical experiments on prisoners. Creation of the Office of the General Plenipotentiary for the Utilization of Labor (March 21, 1942, F. Sauckel). Mass deportation of the population to Germany (A. Hitler's order No. 4 of February 14, 1943).

Topic 2.2. Plunder and destruction of cultural treasures. The "scorched earth" policy. The fight against civilians in partisan zones. Extrajudicial executions of civilians by Nazis and their collaborators. Nazi measures to cover up the traces of crimes in the occupied territories of the RSFSR.

Topic 2.3. Features of the documentary evidence base for crimes against civilians in the occupied territories of the RSFSR during the Great Patriotic War. Information resources containing archival material and sources.

Section 3. Genocide as an international crime

Topic 3.1. Organization of the investigation of crimes of the Nazi troops and their accomplices. 4th Directorate of the NKVD of the USSR. Creation of the Extraordinary State Commission for the Establishment and Investigation of the Crimes of the Nazi Invaders and Their Accomplices (ChGK) (November 2, 1942). Decree of the Presidium of the Supreme Soviet of the USSR "On measures of punishment for Nazi villains guilty of murder and torture of the Soviet civilian population and captured Red Army soldiers, for spies, traitors to the Motherland from among Soviet citizens and for their accomplices" (April 19, 1943). Trials of war criminals on the territory of the USSR (1943-1947).

Topic 3.2. Formation and consolidation of the concept of "genocide" in international law. The London Conference of 1945, the establishment of the International Military Tribunal for the trial and punishment of major war criminals of the European Axis countries. The Nuremberg Trials. "Convention on the Prevention and Punishment of the Crime of Genocide" (December 9, 1948). Investigation of Nazi crimes and trials after Nuremberg. International Covenants on Civil, Political, Economic, Social and Cultural Rights. Convention on the Non-Applicability of Statutory Limitations to War Crimes and Crimes against Humanity. Principles of international cooperation in the detection, arrest, extradition and punishment of persons guilty of war crimes and crimes against humanity. Reflection of the Nuremberg principles in the Rome Statute of the International Criminal Court. International Criminal Court. The place of genocide in the system of crimes against the peace and security of mankind. Jurisdiction over cases of genocide. Problems of regulating and implementing international responsibility for the crime of genocide. The challenges of implementing the norms of international criminal law contained in the Convention on the Prevention and Punishment of the Crime of Genocide of December 9, 1948, into the domestic legislation of the Russian Federation. Article 357 of the Criminal Code of the Russian Federation and the Criminal Code of Germany on International Crimes. Substantive features of the norm on criminal liability for genocide in Russian law. The decision of the Soletsky District Court of the Novgorod Region of October 27, 2020, recognizing the mass executions of Soviet citizens near the village of Zhestyanaya Gorka during the Great Patriotic War as genocide.

7. Features of the organization of educational activities for persons with disabilities and disabled people

Persons with disabilities (PWD) and individuals with disabilities have the opportunity to move freely from one educational and laboratory building to another, ascend to all floors of educational and laboratory buildings, and study in educational and other rooms, taking into account the characteristics of their psychophysical development and health status.

Barrier-free access to all classrooms is provided for students with disabilities and those with musculoskeletal disorders. Information on the special facilities created for students with disabilities and those with disabilities is available on the university website [www//kgeu.ru](http://www.kgeu.ru). Technical assistance is available, as well as sign language and audio-visual interpreters.

To adapt reference and educational material for the course to the needs of individuals with disabilities and those with hearing impairments, the following conditions are ensured:

- To facilitate orientation in the classroom, signals are used to announce the start and end of classes (the word "bell" is written on the board);
- The teacher attracts the attention of a hearing-impaired student with a gesture (a hand is placed on the student's shoulder, gently tapping);
- When speaking to a student, the teacher looks at the student, speaks clearly, in short sentences, and allows for lip reading.

Compensation for speech and intellectual development difficulties in hearing-impaired students is achieved through:

- the use of diagrams, charts, drawings, and computer presentations with hyperlinks that comment on individual image components;
- regular use of exercises to graphically highlight the essential features of objects and phenomena;
- providing students with access to targeted consultations via email as needed.

To ensure that reference, educational, and outreach materials provided by the educational program for the chosen field of study are accessible to individuals with

disabilities and visual impairments, the following conditions are ensured:

- the official website is adapted to the special needs of individuals with visual impairments, and large-font reference information about the class schedule is provided;

- the teaching staff member and their interlocutor (if necessary), present during class, introduce themselves to the student, with the individual being addressed being identified each time;

- the actions, gestures, and movements of the teaching staff member are briefly and clearly commented on;

- printed information is provided in large font (at least 18 points) and is fully audible;

- the required level of room lighting is ensured;

- the opportunity to use computers during classes and to record explanations on a voice recorder (at the student's discretion) is provided.

The format for ongoing and midterm assessments for students with disabilities is determined by the teaching staff in accordance with the curriculum. If necessary, students with disabilities and those with disabilities, taking into account their individual psychophysical characteristics, are given the opportunity to complete midterm assessments orally, in writing on paper, on a computer, through testing, etc., or are given additional time to prepare their responses.

8. Methodological recommendations for teachers on organizing educational work with students

Methodological support for the student development process is one of the defining factors of high-quality education. By demonstrating high professionalism, erudition, a clear civic position, self-discipline, and a creative approach to solving professional problems, university teachers contribute to the development of a well-rounded individual throughout the educational process.

When implementing this course, the teacher may use the following educational methods:

- methods of developing personal awareness (conversation, debate, suggestion, instruction, control, explanation, example, self-control, storytelling, advice, persuasion, etc.);

- methods of organizing activities and developing behavioral experience (assignments, public opinion, pedagogical requirements, instructions, habituation, creating educational situations, training, exercises, etc.);

- methods of motivating activity and behavior (approval, encouragement of social activity, reprimand, creating situations of success, creating situations for emotional and moral experiences, competition, etc.)

When implementing the discipline, the teacher must take into account the following areas of educational activity:

Civic and Patriotic Education:

- developing in students a holistic worldview, Russian identity, respect for their family, society, and state, the spiritual, moral, and sociocultural values accepted in the family and society, and respect for the national, cultural, and historical heritage, as well as a desire to preserve and develop it;

- developing in students an active civic position based on the traditional cultural, spiritual, and moral values of Russian society, to enhance their ability to responsibly exercise their constitutional rights and responsibilities;

- developing students' legal and political awareness, expanding their constructive participation in decision-making affecting their rights and interests, including through various forms of self-organization, self-government, and socially significant activities;

- developing motivations, moral, and meaningful attitudes that enable them to resist extremism, xenophobia, discrimination based on social, religious, racial, and national grounds, interethnic and interfaith intolerance, and other negative social phenomena.

Spiritual and moral education:

- fostering a sense of dignity, honor, and honesty, conscientiousness, and respect for parents, teachers, and the elderly;

- developing the principles of collectivism and solidarity, a spirit of mercy and compassion, and a habit of caring for those in difficult life situations;

An "excellent" grade is awarded for high-quality performance on test assignments, written assignments, reports, media presentations, and essays; a deep understanding of the controversial issues and questions raised for discussion; full compliance with the requirements of the research project (assignment) and business simulation; complete and meaningful answers to test questions; a systematic presentation of the acquired knowledge about the subject, manifested in the free manipulation of concepts, the ability to identify its essential and non-essential features, and cause-and-effect relationships. The answer is formulated using scientific categorical and conceptual frameworks, presented consistently, logically, and convincingly, demonstrating the student's authorial position.

A "good" grade is awarded for the completion of assignments, written assignments, media presentations, and essays; a thorough understanding of the controversial issues and questions raised for discussion; full compliance with the requirements of the research project; complete and informative answers to assessment questions, demonstrating a comprehensive understanding of the subject matter, and convincingly explaining the main concepts of the topic; the answer demonstrates a clear structure and logical sequence, reflecting the essence of the concepts, theories, and phenomena being explored. The answer is presented consistently, logically, and convincingly; however, there are some deficiencies in the definitions of concepts, which the student corrects independently during the answer process.

A "satisfactory" grade is awarded for completing test assignments, reports, and media presentations; participating in discussions; and providing a complete, but not entirely coherent, answer to the question posed, demonstrating the ability to identify essential and non-essential features and cause-and-effect relationships. The answer is logical and presented in scientific language. Two or three errors in defining key concepts may be made, which the student is unable to correct independently.

A grade of "unsatisfactory" is given for weak or incomplete completion of test assignments, failure to complete essays, failure to participate in discussions, or for providing an incomplete answer during the test, representing fragmented knowledge on the topic of the question with significant errors in definitions. The student's presentation is fragmented and illogical. The student fails to recognize the connections between concepts, conceptual intersections, and structural patterns between various discipline objects. Conclusions are lacking, and the presentation lacks specificity and evidence. Speech is illiterate. Additional and clarifying questions from the teacher do not lead to a correction of the student's answer not only to the question posed, but also to other questions in the discipline.
